## LATEST ANNUAL REPORT FOR THE YEAR 2015-'16

OUR SOCIETY HAS BEEN REGISTERED UNDER SOCIETIES REGISTRATION ACT 35 OF 2001 CONSTITUTED BY A COMMITTEE OF SEVEN MEMBERS KNOWN AS MANAGING COMMITTEE.

THE MAIN OBJECTIVES OF THE ORGANIZATION IS TO EDUCATE PEOPLE AND MAKE THEM CONSCIOUS AND CONCERNED ABOUT SELF-RELIANCE , SOCIAL JUSTICE TO ERADICATE ILLITERACY POVERTY AND MISERY WITHOUT DISCRIMINATION OF CASTE, CREED, COLOUR AND COMMUNITY. THE FOLLOWING ACTIVITIES HAS BEEN TAKEN UP DURING THIS YEAR.

IN PSYCHOLOGICAL THERAPY FOR TREATMENT SERVICES DURING THE YEAR 2015-16 THE CENTER PROVIDED 254 GROUP CONSELING SESSIONS FOR 435 GROUPS CONSISTING OF FIVE CLIENTS IN EACH GROUP. INDIVIDUAL COUNSELING SESSIONS PROVIDED FOR 210 CLIENTS WITH 712 SESSIONS. THE 198 FAMILY MEMBERS RECEIVED FAMILY COUNSELING FOR 715 SESSIONS.

AMONG THE INPATIENT TREATMENT SERVICES 265 NOS OF CLIENTS RECOVERED TOTALLY AND THEY ARE IN SOBRIETY. THE REMAINING no NOS OF CLIENTS RELAPSED AND THEY ARE RECEIVING FOLLOW UP SERVICES AND RECEIVED ART THERAPY FOR RECOVERY.

IN SPECIALISED SERVICES REFERRAL SERVICES PROVIDED AND MONITORED. THEY WERE no NOS OF 2 TB CASES , 04 NOS OF HIV CASES, 20 NOS OF STD CASES, no NOS OF HEPATITIS A OR B, AND 07 NOS OF ABSCESS CASES ETC.,
